What is this product?

This product has no specific maturity date. In certain circumstances, as described in the Fund prospectus, the Sub-Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

Objectives

The investment objective of the Fund is to provide capital growth in excess of the Target Performance Benchmark ("MSCI World Index") over a rolling five year period, through investment in an actively managed, concentrated global share portfolio. There can be no assurance that the Fund will achieve its investment objective.

The Sub-Investment Manager shall seek to achieve the investment objective by investing in shares of globally listed growth companies, at least 90% of which shall meet the Investment Manager's definition of a Quality Franchise and are listed in a country that has been rated by the Institute for Economics & Peace ("IEP") through the Positive Peace Index ("PPI") as being very high ("Very High"). The remaining 10% of the Fund's equity investments may comprise companies that do not immediately qualify as Quality Franchises at the point of acquisition by the Fund, but which will be expected to meet the criteria within five years of such date.

Quality Franchises means those high-quality businesses that the Investment Manager determines to be in the growth stage of their life cycle, and which have the ability to generate predictable, above average returns and produce superior investment performance over the long-term.

The Fund may also invest up to 20% of its Net Asset Value in cash or cash alternatives (such as money market instruments, or cash held on deposit), and Collective Investment Schemes (including other funds managed by the Investment Manager or its affiliates).

The Fund is actively managed with reference to the MSCI World Index, meaning the Investment Manager uses their expertise to select investments to achieve the Fund's objectives.

Intended Retail Investor

The ECP Global Growth Fund is appropriate for Retail Investors, Basic, Informed and Advanced. The Fund is appropriate for investors who are seeking long-term returns. The fund may not be appropriate for investors that plan to withdraw their money within 5 years. Investors should be aware that 100% of their capital is at risk and investment is not appropriate for investors who seek a capital guarantee or can bear no capital loss including minor losses. The fund is not designed to preserve or limit capital loss.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes that you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the PRIIPs manufacturer to pay you.

Due to effects of unusual market conditions, other risks could be triggered, such as: concentration risk, currency risk, equity securities risk, liquidity risk, market risk and volatility risk.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance Scenarios

Recommended holding period: 5 years
